The true and actual consideration for this conveyance is **\$69,000.00**.

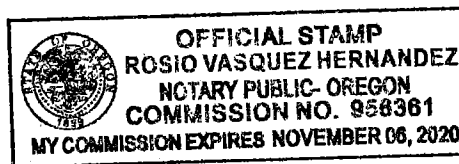
