THIS INDENTURE, made 7/17/2017, between CLEAR RECON CORP. hereinafter called trustee, and **DITECH FINANCIAL LLC**, hereinafter called the second party:

WITNESSETH:

RECITALS: DEBRA C. THADEN, AN UNMARRIED WOMAN, as grantor, executed and delivered to FIRST AMERICAN TITLE INSURANCE CO. OF OR, for the benefit of MORTGAGE ELECTRONIC REGISTRATION SYSTEMS INC., SOLELY AS NOMINEE FOR SUNTRUST MORTGAGE, INC., ITS SUCCESSORS AND ASSIGNS, as beneficiary, a certain Trust Deed dated 4/22/2005, duly recorded on 4/27/2005, in Book M05, Page 29900,, in the mortgage records of Klamath County, Oregon.
