The true and actual consideration for this conveyance is **\$425,000.00**.

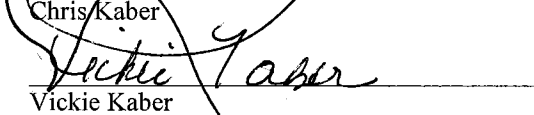

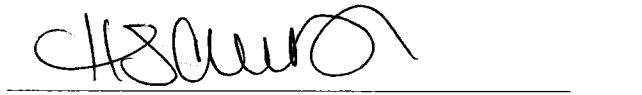
