STATUTORY WARRANTY DEED

Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

A tract of land situated in the S1/2 of the SW1/4 of the NW1/4 of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows

Beginning at a point on the East-West quarter line which lies North 88° 57' East a distance of 806.50 feet from the iron axle which marks the one-quarter section corner common to Sections 10 and 11, Township 39 South, Range 9 East of the Willamette Meridian, and running thence; continuing North 88° 57' East a distance of 75.5 feet allong the East-West quarter line, thence North 1° 12' West parallel to the West Section line of said Section 11, a distance of 331.4 feet to a point, thence South 88° 57' West parallel to the East-West quarter line a distance of 75.5 feet to a point South 1° 12' East a distance of 331.4 feet, more or less, to the point of beginning, Except any portion lying within Winter Avenue.

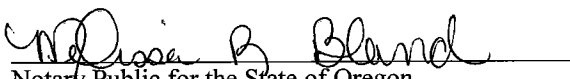
