DEED

(to Successor Trustee)

1. RECITALS: On April 27, 1990, Donald G. Oliphant and Bertha S. Oliphant, as Trustors and Trustees, executed the Oliphant Loving Trust dated April 27, 1990.

A. Trustor Donald G. Oliphant died on January 24, 2006.

B. After the death of Donald G. Oliphant, the Oliphant Loving Trust was divided into the Donald G. Oliphant Family Trust and the Oliphant Marital Trust.

C. Bertha S. Oliphant, as sole surviving Trustee of the Donald G. Oliphant Family Trust and the Oliphant Marital Trust entered into a Trust Settlement Agreement dated October 23, 2015, whereby Guy Donald Oliphant, and Lisa Ann Waterman would serve as Co-Trustees along with Bertha S. Oliphant. The agreement provides upon the resignation, incapacity or death of any of the Co-Trustees, the remaining Co-Trustees or Trustee shall continue as Co-Trustees or Trustee.

D. Bertha S. Oliphant died October 30, 2016.

2. TRUSTEE ACCEPTANCE AND CONVEYANCE: Guy Donald Oliphant and Lisa Ann Waterman, by their subscription hereto, hereby acknowledge assumption of their duties as Successor Co-Trustees and do hereby convey title to all of the trust estate, including any real property hereinafter described, to Guy Donald Oliphant and Lisa Ann Waterman, Successor Trustee of the Donald G. Oliphant Family Trust initially of April 27, 1990, subject to the terms of the trust and they shall have all of the powers of the original Trustees.

3. CONSIDERATION: The true consideration for this conveyance is \$none. This conveyance is made pursuant to the administrative provisions of the trust described above.

4. REAL PROPERTY DESCRIPTION: This conveyance affects the real property, situated in Klamath County, Oregon, described on the attached Exhibit A.

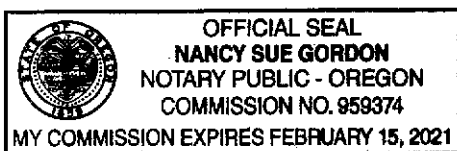

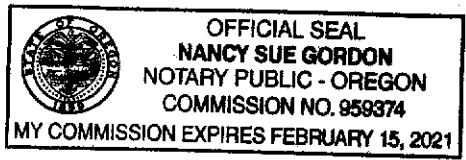


EXHIBIT "A"
