Lot 56 of Skyline View, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

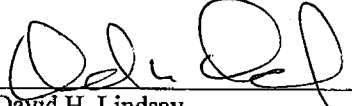

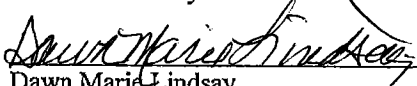

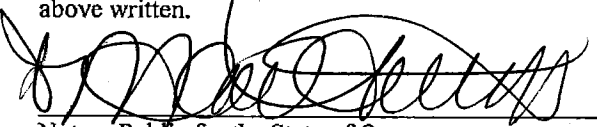
