WHERAS, this real and personal property was purchased for the sum of \$31,000.00. Down payment of \$7,750.00 plus \$42.00 recording fee was paid on June 9th 2016. With annual installments due in the sum of \$11,625.00 for following years.

WHEREAS, Enriqueta Deaton has failed to fulfill her Land Sale Agreement obligations to Klamath County. Klamath County Property Taxes are currently delinquent on the above referenced property for the current year assessed and no proof of insurance has been submitted.

WHEREAS, the Board of County Commissioners finds it in Klamath County's best interest to cancel the current land sale agreement with Enriqueta Deaton for the property located at 100525 Hwy 97N, Chemult, OR, further described as: Parcel 1 of Land Partition 127-06, located in the NW 1/4 of Section 20, Township 28 South, Range 08 East of the Willamette Meridian, Klamath County Oregon.
