## SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT ("Agreement") is made and entered into this 18<sup>th</sup> day of August 2017 by and between **OREGON AFFORDABLE HOUSING ASSISTANCE CORPORATION** with an address of 725 Summer Street NE, Suite B, Salem OR 97301-1266, hereinafter called the "First Party" and Flagstar Bank, FSB, with an address of 5151 Corporate Drive, Troy, MI 49098 hereinafter called the "Second Party".

## WITNESSETH:

On or about May 31, 2013, Brenda L. Miller, being the owner (referred to hereinafter as the "Owner" or "Borrower") of property located in Klamath County, Oregon and described on Exhibit A hereto (the "Premises"), executed and delivered to the First Party a certain SUBORDINATE MORTGAGE (herein called the "First Party Lien") on the Premises, to secure the sum of \$30,000.00, which lien was recorded on June 17, 2013, in the Records of Klamath County, Oregon as Document No. 2013-006798.

The First Party is the legal and beneficial owner of the First Party Lien and the debt secured thereby which is evidenced by one or more promissory notes made by the Borrower in favor of the First Party.

Borrower's current first mortgage loan on the Premises securing an estimated unpaid principal balance of \$60,234.34, in favor of Sterling Savings Bank, recorded on December 1, 2005, in the Records of Klamath County, Oregon, as Document No. M05, page 70266 and Borrower's current second mortgage loan on the premises securing an estimated unpaid principal balance of \$25,089.93 in favor of Sterling Savings Bank, recorded on November 30, 2007, in the Records of Klamath County as Document No. 2007-020174 which liens and the underlying debt shall be terminated upon such refinancing.

The First Party and the Second Party agree that the principal amount of such refinancin	ıg

To induce the Second Party to make the loan last mentioned, the First Party has agreed and consented to subordinate First Party's Lien to the Second Party's Lien.

NOW, THEREFORE, for value received, and for the purpose of inducing the Second Party to make the loan aforesaid the First Party hereby agrees that the First Party's Lien is and shall be expressly subordinate and junior to the Second Party's Lien.

It is expressly understood and agreed that nothing herein contained shall be construed to change, alter or impair the First Party's Lien, except as herein above expressly set forth.

In construing this Agreement, and where the context so requires, the singular includes the plural, and all grammatical changes shall be made so that this agreement shall apply equally to corporations and to individuals.

IN WITNESS WHEREOF, the undersigned have executed this Agreement. If the undersigned is a corporation, it has caused its name to be signed and its seal, if any, affixed by an officer or other person duly authorized to do so by order of its board of directors.
