The true and actual consideration for this conveyance is \$93,000.00.

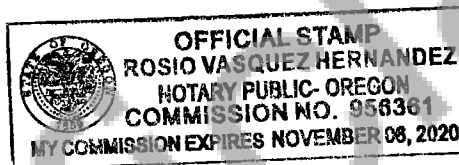


