

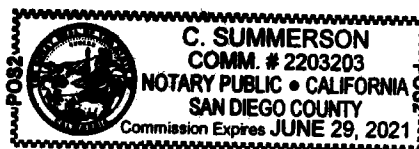



NOTICE TO RESIDENTIAL TENANTS



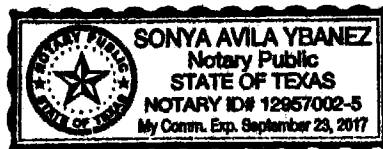

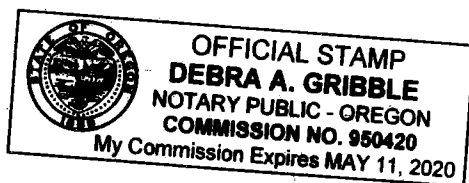
