THIS INDENTURE, made 8/31/2017, between CLEAR RECON CORP. hereinafter called trustee, and MORTGAGE RESEARCH CENTER, LLC D/B/A VETERANS UNITED HOME LOANS, A MISSOURI LIMITED LIABILITY COMPANY, hereinafter called the second party:

#### WITNESSETH:

RECITALS: DAVID R PREWITT, JR., MARRIED MAN, as grantor, executed and delivered to NEXTITLE, for the benefit of MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. ("MERS"), AS DESIGNATED NOMINEE FOR MORTGAGE RESEARCH CENTER, LLC DBA VETERANS UNITED HOME LOANS, BENEFICIARY OF THE SECURITY INSTRUMENT, ITS SUCCESSORS AND ASSIGNS., as beneficiary, a certain Trust Deed dated 5/7/2015, duly recorded on 5/8/2015, as Instrument No. 2015-004643,, in the mortgage records of Klamath County, Oregon.
