THIS INDENTURE, Made this 09/06/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and WELLS FARGO BANK, N.A., hereinafter called the grantee;

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV04853, Klamath County Sheriff's Office Number J16-0076, in which WELLS FARGO BANK, N.A. was plaintiff(s) and TIMOTHY D. NEWELL; TAMMY L.
