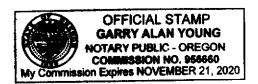

PARCEL 1.

A tract of land situated in the E1/2 of Section 13, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at a point on the Southerly line of Parcel described in Deed Volume 244, page 51, Deed Records of Klamath County, Oregon, which bears South 0 degrees 12' 57" West, 1059.29 feet, and South 72 degrees 58' 63" West 916:72 feet from the Northeast corner of said Section 13, said beginning point being the most Westerly corner of tract described in Hemorandum of Agreement recorded in Volume M77, page 24109, Hicrofilm Records of Klamath County, Oregon; thence continuing along the Southerly line of Parcel described in Deed Volume 244, page 41, South 72 degrees 58' 03" West a distance of 729.63 feet, more or less, to an angle point; thence South 18 degrees 36" East 30.9 feet, thence South 71 degrees 43' West along said Southerly line to the Northeasterly right-of-way line of the U.S.B.R.
