
Lots 5 and 6 in Block 3, Lenox, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

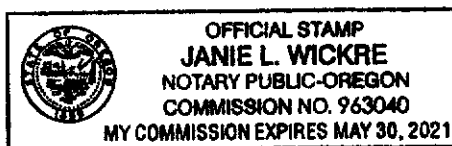
