STATUTORY WARRANTY DEED

Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

Lot 61 of LAMRON HOMES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, ALSO a 15 foot strip of land situated in the S1/2 SW1/4 SE1/4 of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at the Southeast corner of Lot 61, LAMRON HOMES SUBDIVISION, according to the duly recorded plat thereof; thence South 0° 07' East a distance of 15 feet to the South line of Section 11; thence North 89° 56' West along the South line of said Section 11, a distance of 85 feet; thence North 0° 07' West a distance of 15 feet to the Southwest corner of said Lot 61; thence South 89° 56' East along the South line of said Lot 61 a distance of 85 feet, more or less, to the point of beginning.
