**Description of real property:** Parcel 1: The E1/2 of the W1/2 of the SE1/4 of the SW1/4 of Section 2, Township 36 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon. Parcel 2: The W 1/ 2 of the E 1/2 of the SE 1/4 of the SW 1/ 4 of Section 2, Township 36 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon. Parcel 3: Lot 23, Block 32, Fourth Addition to Nimrod River Park, according to the official plat thereof on file in the office of the Clerk of Klamath County, Oregon. **Subject to covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.**


To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

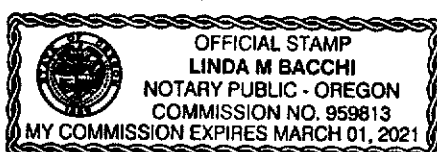


