THIS INDENTURE, Made this 10/23/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV00710, Klamath County Sheriff's Office Number J16-0107, in which EVERBANK was plaintiff(s) and KIRT BROWN; CHRISTY J. 
