THIS INDENTURE, Made this 10/31/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and BEVERLY J HANSON TRUST, FBO DARRYL PECH, TODD GOEBEL, TRUSTEE, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV06662, Klamath County Sheriff's Office Number J16-0088, in which NATIONSTAR MORTGAGE LLC was plaintiff(s) and CHRISTOPHER W. BELAND; OREGON AFFORDABLE HOUSING ASSISTANCE CORPORATION; STATE OF OREGON, HEATHER BELAND; PARTIES IN POSSESSION was defendant(s), in which a Writ of Execution, which was issued on 08/22/2016, directing the sale of that real property, pursuant to which, on 04/28/2017 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$106,000.00 to TODD GOEBEL, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 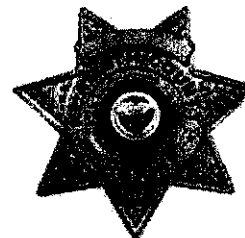
