RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1501700CV, Klamath County Sheriff's Office Number J16-0113, in which M&T BANK was plaintiff(s) and WAYNE A. POWELL II, AN INDIVIDUAL; JENNIFER L. 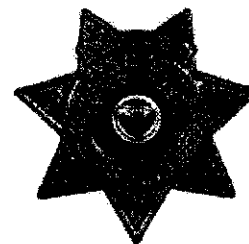
