Lot 13 Block 1, Rolling Hills, Tract 1099, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

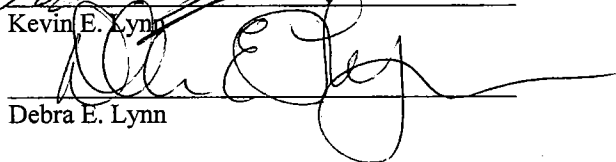
