- 1. Property affected: 3831 Scott Valley Dr., 38S09E15D, tax lot 2700 in Klamath Falls, Klamath County, Oregon (the "Property") the location of which is more particularly described in Exhibit A to this notice. The Property is zoned for low density residential (RL) and is currently a vacant residential home.
- 2. This Notice of Environmental Contamination supersedes previously recorded notices.
- 3. A limited area of the Property is located within the boundaries of the North Ridge Estates (NRE) Site, Operable Unit No. 1 (OU1). Investigations performed by the United States Environmental Protection Agency (EPA) have documented asbestos containing materials (ACM) in this area of the Property either at the surface and/or in the subsurface. The location of the ACM documented on the Property is shown in Exhibit B.
- 4. Asbestos presents a health hazard when friable and released to the environment.
- 5. Remedial actions were performed on the Property in 2016 and 2017 by EPA. Remedial actions included the excavation and off-Property disposal of contaminated soil and materials, backfilling and construction of a protective cap, and restoration.
- 6. The purpose of this deed notice is to provide notice that ACM may remain in the portion of the Property shown in Exhibit B beneath the two foot soil protective cap.
- 7. The Department of Environmental Quality (DEQ) should be notified prior to any redevelopment or disturbance of the soils at the Property in the area defined in Exhibit B of this notice. For more information regarding this notice, contact DEQ, Cleanup Program, Eastern Region, 800 SE
