
APPOINTMENT OF SUCCESSOR TRUSTEE



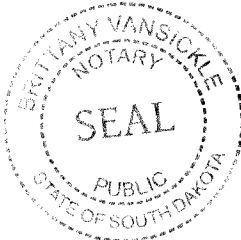
