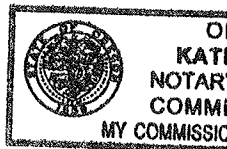

THIS INDENTURE, Made this 12/11/2017, by and between Chris Kaber, Sheriff of Klamath County,
Oregon, hereinafter called the grantor, and FEDERAL NATIONAL MORTGAGE ASSOCIATION, hereinafter called
the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV02136, Klamath County Sheriff's Office Number J16-0133, in which NATIONSTAR MORTGAGE LLC was plaintiff(s) and JASON DERRA; REBECCA DERRA; OREGON AFFORDABLE HOUSING ASSISTANCE CORPORATION; AND PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE LIEN, OR INTEREST IN THE PROPERTY DESCRIBED IN THE COMPLAINT HEREIN was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 11/16/2016, directing the sale of that real property, pursuant to which, on 04/03/2017 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$148,940.00, to NATIONSTAR MORTGAGE LLC, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 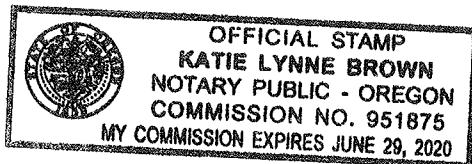
