THIS INDENTURE, Made this 12/11/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association ("Fannie Mae"), hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV11393, Klamath County Sheriff's Office Number J16-0123, in which Federal National Mortgage Association ("Fannie Mae") was plaintiff(s) and JAMES J.
