SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT ("Agreement") is made and entered into this 11th day of December 2017, by and between **OREGON AFFORDABLE HOUSING ASSISTANCE CORPORATION** with an address of 725 Summer Street NE, Suite B, Salem OR 97301-1266, hereinafter called the "First Party" and Quicken Loans., Inc. ISAOA, with an address of 1050 Woodward Ave, Detroit, MI 48226, Anaheim, CA 92806 hereinafter called the "Second Party".

WITNESSETH:

On or about April 18, 2012, Steven E. Quick and Cindy L. Quick, being the owner (referred to hereinafter as the "Owner" or "Borrower") of property located in Klamath County, Oregon and described on Exhibit A hereto (the "Premises"), executed and delivered to the First Party a certain SUBORDINATE MORTGAGE (herein called the "First Party Lien") on the Premises, to secure the sum of \$30,000.00, which lien was recorded on May 2, 2012, in the Records of Klamath County, Oregon as Document No. 2012-004591.
