KNOW ALL MEN BY THESE PRESENTS, That

hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

Lots 10 and 11, Block 4 of North Beaver Marsh Addition, according to the official plat thereof, on file in the office of the County Clerk of Klamath County, Oregon.

The true and actual consideration paid for this transfer, stated in terms of dollars, is to convey title.
