4. The grantor warrants and will defend the title to the property against all persons who may lawfully claim the same.

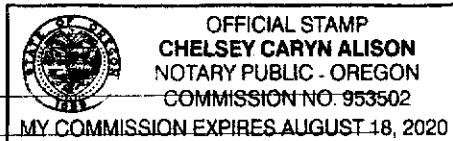
