The true and actual consideration for this conveyance is \$159,000.00.

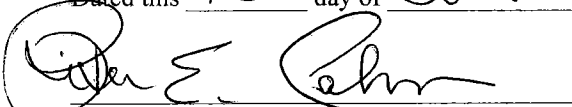

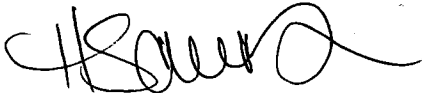
