THIS INDENTURE, Made this 12/28/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and U.S. BANK NATIONAL ASSOCIATION, NOT IN ITS INDIVIDUAL CAPACITY BUT SOLELY AS TRUSTEE FOR THE RMAC TRUST, SERIES 2016-CTT, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV00910, Klamath County Sheriff's Office Number F17-0099, in which U.S. BANK NATIONAL ASSOCIATION, NOT IN ITS INDIVIDUAL CAPACITY BUT SOLELY AS TRUSTEE FOR THE RMAC TRUST, SERIES 2016-CTT was plaintiff(s) and MICHAEL A. LITTLE; PARTIES IN POSSESSION was defendant(s), in which a Writ of Execution, which was issued on 04/13/2017, directing the sale of that real property, pursuant to which, on 09/08/2017 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$45,960.60, to U.S. BANK NATIONAL ASSOCIATION, NOT IN ITS INDIVIDUAL CAPACITY BUT SOLELY AS TRUSTEE FOR THE RMAC TRUST, SERIES 2016-CTT, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 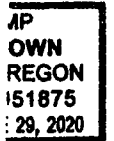
