RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1500600CV, Klamath County Sheriff's Office Number F17-0094, in which BANK OF AMERICA, N.A. was plaintiff(s) and VICKI T. 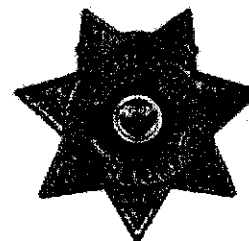
