The following described real property is situate in Klamath County, Oregon, being more particularly described as follows:

Commencing at the corner common to Sections 21, 22, 27 and 28, Township 39 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, thence West, along the South boundary of Section 21, 2,041.10 feet; thence North 3° 37' West, 2,059.08 feet to the true point of beginning; thence South 84° 00' West to the North-South centerline of Section 21; thence North along said line to the center one-quarter corner of said Section 21; thence East, along the East-West centerline of said Section 21, to the Langell Valley Irrigation District North Canal; thence Southerly along said canal to a point due East of the true point of beginning; thence West to the true point of beginning.
