THIS INDENTURE, Made this 12/28/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and WELLS FARGO BANK, N.A., hereinafter called the grantee;

WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV01937, Klamath County Sheriff's Office Number J16-0073, in which WELLS FARGO BANK, N.A., was plaintiff(s) and MELVA J. THOMPSON; SECRETARY OF HOUSING AND URBAN DEVELOPMENT; DISCOVER BANK; AND ALL OTHER PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE REAL PROPERTY COMMONLY KNOWN AS 149011 SNUFFY DR., LA PINE, OR 97739, was defendant(s), in which a Writ of Execution, which was issued on 06/03/2016, directing the sale of that real property, pursuant to which, on 12/14/2016 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$114,227.36, to WELLS FARGO BANK, N.A., who was the highest and best bidder, that sum being the highest and best sum bid therefore. 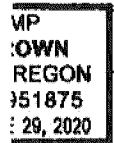
