MINERALS QUITCLAIM DEED (OR)

TRISTAR SOUTHWEST OREGON TIMBERLANDS LLC, a Delaware limited liability company, with an address as c/o Hancock Natural Resource Group, Inc., 197 Clarendon Street, C-08-99, Boston, MA 02116, formerly known as Meriwether Southern Oregon Land & Timber, LLC, a Delaware limited liability company ("Grantor"), hereby releases and quitclaims to CASCADE AGGREGATE RESOURCES, LLC, an Oregon limited liability company, with an address at 4815 Tingley Lane #A, Klamath Falls, OR 97603 ("Grantee"), all of Grantor's right, title and interest in and to (i) all Minerals (as this term is defined below) owned by Grantor in, on or under the real property situated in the County of Klamath, State of Oregon and more particularly described in the attached Exhibit A (the "Premises"), and (ii) any and all other Minerals that may be owned by Grantor in Klamath County but not particularly described herein; together with any and all rights and limitations recognized under Oregon law that may be ancillary or appurtenant thereto, subject to all matters of record affecting the Premises and the Minerals.
