thence, N 84°28'29" W, 1227.53 feet to the TRUE POINT OF BEGINNING of this line;

thence, S 0°53'08" W, 10 feet, more or less, to a point on the northerly line of the 60-foot wide right of way (State Route 161) described in the letter from the Project Manager of the Region 2 Office of the U.S. Bureau of Reclamation, Klamath Falls, Oregon to the District Engineer of the Office of the Division of Highways, State of California, Redding, California dated October 27, 1959 and filed in Parcel File No. 9429 in the records of the Right of Way Department of the California Department of Transportation, Redding, California, being the POINT OF TERMINATION of this line.

The sidelines of said strip of land are to be prolonged or shortened so as to end on said northerly line.
