A portion of Tract 70, ENTERPRISE TRACTS, described as follows:

Beginning at a point on the Southerly right-of-way line of South Sixth Street, as the same is presently located and constructed, at its intersection with a line parallel with and 390.0 feet West of the East line of said Tract 70, said point being South 0° 03' 45" West a distance of 12.08 feet from the Northeasterly corner of tract conveyed to Marshall E. Cornett and Olive B. Cornett, husband and wife, by Deed Volume 111, page 399, Deed Records of Klamath County, Oregon, thence continuing South 0° 03' 45" West along the East line of last mentioned tract, a distance of 171.92 feet, more or less, to a point which is East 17.5 feet from the Northeast corner of tract conveyed to Richfield Oil Corporation by Deed Volume 139, page 65, Deed Records of Klamath County, Oregon; thence West along the North line of last mentioned tract a distance of 144.2 feet, to the West line of Cornett Tract described in Deed Volume 111, page 399, Deed Records of Klamath County, Oregon; thence North 0° 03' 45" East along said West line to the Southerly corner of tract conveyed to Safeway Stores, Inc. by Deed Volume 248, page 374, Deed Records of Klamath County, Oregon; thence North 34° 09' 30" East along the Southeasterly line of last mentioned tract, a distance of 122.5 feet to the Southerly right-of-way line of South Sixth Street; thence South 55° 50' 30" East along said right-of-way line, a distance of 92.07 feet, more or less, to the point of beginning.
