THIS INDENTURE, Made this 01/29/2018, by and between Chris Kaber, Sheriff of Klamath County,

WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1501079CV, Klamath County Sheriff's Office Number F17-0090, in which BANK OF AMERICA, N.A. was plaintiff(s) and HIEN T. PHAM, AN INDIVIDUAL; GARY G. 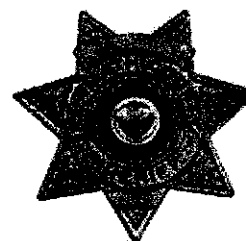
