PARCEL 1:

Beginning at the most Northerly corner of Lot 8, Block 55 of NICHOLS ADDITION to the City of Klamath Falls, Oregon, Klamath County, Oregon; thence Southeasterly along the Southerly line of Ninth Street a distance of 60 feet; thence at right angles to Ninth Street Southwesterly a distance of 65 feet to the Southerly line of said Lot 8 parallel with Ninth Street a distance of 60 feet to the Easterly line of Lincoln Street; thence Northeasterly along the Easterly line of Lincoln Street a distance of 65 feet, more or less, to the point of beginning.
