WARRANTY DEED

KNOW ALL BY THESE PRESENTS that DOUGLAS J. YOUNGBERG AND BEVERLY G. YOUNGBERG, hereinafter called grantor, for the consideration hereinafter stated, do hereby grant, bargain, sell and convey unto DOUGLAS J. YOUNGBERG AND BEVERLY G. YOUNGBERG, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE YOUNGBERG LIVING TRUST DATED FEBRUARY 20, 2018, AND ANY AMENDMENTS THERETO, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in **Klamath** County, State of Oregon, described as follows, to-wit:

The liability and obligations of the Grantor to Grantee and Grantee's heirs and assigns under the warranties and covenants contained herein or provided by law shall be limited to the extent of coverage that would be available to Grantor under any policy of title insurance issued to the Grantor at the time Grantor acquired the property. The limitations contained herein expressly do not relieve Grantor of any liability or obligation under this instrument, but merely define the scope, nature and amount of such liability or obligations.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.


And grantor hereby covenants to and with grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except: NONE, and that grantor will warrant and forever defend the premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

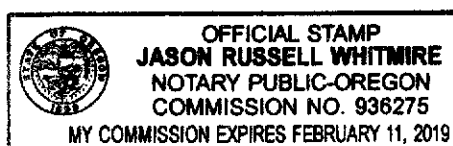


