RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV02225, Klamath County Sheriff's Office Number F17-0083, in which DITECH FINANCIAL, LLC was plaintiff(s) and ANNETTE L. DOMELA; AND ALL OTHER PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN OR INTEREST IN THE REAL PROPERTY COMMONLY KNOWN AS 311 E. 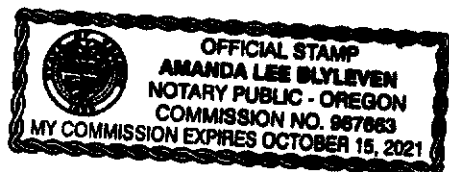
