THIS INDENTURE Made this 14th day of March, 2018, by and between

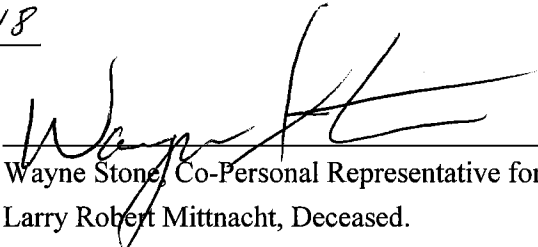
Lot 15, TRACT 1432 - Quail Point Estates, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

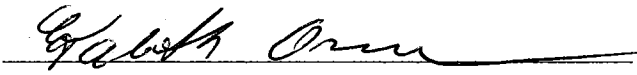

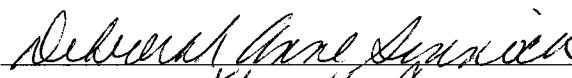
