THIS INDENTURE, Made this 03/26/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and FRED AND SUSAN GARLAND, hereinafter called the grantee;

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV40978, Klamath County Sheriff's Office Number F17-0104, in which ENTERPRISE IRRIGATION DISTRICT was plaintiff(s) and JULIE DIANE HORNBuckle; MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC.
