PARCEL 1

Beginning at the Northwest corner of Lot 9, Block 60, Nichols Addition to Linkville, now Klamath Falls, Oregon; thence East 76.1 feet, more or less, to a point 100 feet West of the Northeast corner of said Lot 9; thence at right angles South 102 feet, more or less, to the Northeasterly line of Lots 1 and 8, Block 60; thence Northwesterly 119 feet, more or less, along said Northeasterly line of Lots 1 and 8 to the Easterly line of Franklin Street; thence North along said Easterly line of Franklin Street 33 feet, more or less, to the Northwest corner of said Lot 9, the point of beginning.

ALSO Beginning at a point 40 feet South of the Northeast corner of said Lot 9, on the West line of Lincoln Street, formerly Washington Street; thence West at right angles to Lincoln Street 100 feet; thence South at right angles 42 feet; thence Easterly to the West line of Lincoln Street at a point 58 feet South of the point of beginning; thence North 58 feet along the West line of Lincoln Street to the point of beginning.

PARCEL 2

The Northeasterly 43-1/3 feet of Lot 1 in Block 60 of Nichols Addition to the City of Klamath, Oregon.

Two portions of Lot 9, Block 60, Nichols Addition to the City of Klamath Falls, Oregon, described as follows: Beginning at a point 138 feet South of the Northeast corner of said Lot 9 on the West line of Lincoln Street; thence Westerly to a point 100 feet West and 92 feet South of the said Northeast corner of said Lot 9; thence Southerly 10 feet, more or less, to the Northwest corner of Lot 1 of said Block 60; thence Southeasterly along the Northeasterly line of said Lot 1 of Lincoln Street; thence North 40.22 feet, more or less, to the point of beginning.
