EXHIBIT "A" LEGAL DESCRIPTION

A parcel of land situated in the SE1/4 of the SE1/4 of Section 10; the SW1/4 of the SW1/4 of Section 11; the NW1/4 of the NW1/4 of Section 14; and the NE1/4 of the NE1/4 of Section 15, Township 38 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.
