THIS INDENTURE, Made this 11/09/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and CAPITAL INDUSTRIES, INC. TRUSTEE, DAWN TRUST, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 15CV27281, Klamath County Sheriff's Office Number J16-0111, in which CITIMORTGAGE, INC. was plaintiff(s) and CHRISTOPHER MOLINEAUX; OCCUPANTS OF THE PROPERTY LOCATED AT 1732 DAWN DRIVER, KLAMATH FALLS, OR 97603; OCCUPANTS OF THE PROPERTY LOCATED AT 1736 DAWN DR, KLAMATH FALLS, OR 97603 was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 10/12/2016, directing the sale of that real property, pursuant to which, on 04/19/2017 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$109,266.00, to CAPITAL INDUSTRIES, INC.
