Parcel 1:

Beginning at a 1/2" iron pipe from which the record position of the 1/4 corner common to Sections 31 and 32 bears North 37°29'10" West 206.81 feet to a stone monument with a chiseled cross and South 41° West 1094 feet, more or less; thence South 07°10'00" West 27.47 feet to a 5/8" iron pin; thence South 42°53'50" East 205.55 feet to a 5/8" iron pin; thence North 43°12'40" East 189.91 feet to the right of way line of Conger Avenue; thence along said right of way line North 48°36'51" West 158.57 feet, South 47°24'25" West 77.06 feet and North 58°57'21" West 15.71 feet; thence South 74°34'00" West 80.25 feet to the point of beginning.

Said parcel being Parcel 1 of Major Land Partition 2-MP-90 situated in Government Lot 8 of Section 32, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon.
