The Easterly 75 feet of Lot 15 of Burnsdale, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

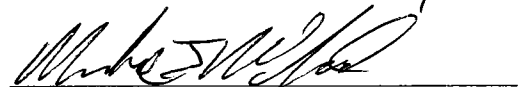

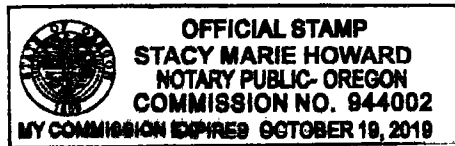


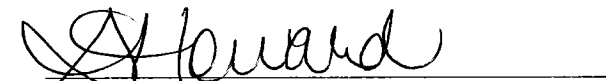
