EXHIBIT "A"

That portion of the following described property lying within the SW1/4 NW1/4 of Section 11, Township 35 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at the Northwest corner of a tract of land conveyed to Laurence Myers and wife by deed recorded May 31, 1968, in M68, page 4893, Microfilm Records of Klamath County, Oregon, said corner being South 89° 21' 50" East 1203 feet, North parallel to the West line of said NW1/4 a distance of 480 feet, due West 325 feet and due North 559 feet, more or less from the Southwest corner of said NW1/4; thence from said point of beginning running Westerly along the Southerly line of Sprague Road a distance of 400 feet; thence South parallel to the West line of said Myers tract a distance of 630 feet; thence due East to the West line of said Myers tract; thence North along the West line of said Myers tract to the point of beginning.
