THIS INDENTURE, Made this 05/21/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and MTGLQ INVESTORS, L.P., hereinafter called the grantee;
WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 17CV13474, Klamath County Sheriff's Office Number F17-0200, in which MTGLQ INVESTORS, L.P., ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and BEN F. MITCHELL AKA BEN FAYE MITCHELL; KATHLEE J. MITCHELL AKA KATHLEEN JAMELL MITCHELL; MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. 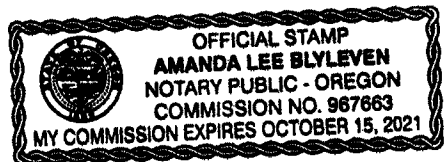
