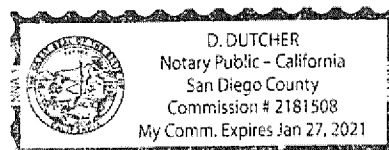



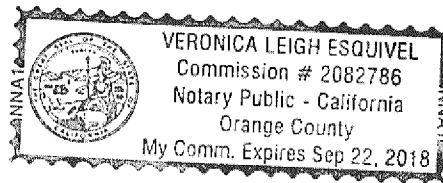

NOTICE TO RESIDENTIAL TENANTS
