THIS MODIFICATION OF DEED OF TRUST dated May 25, 2018, is made and executed between Howard J Tompkins and Cynthia F Tompkins, as tenants by the entirety, whose address is 5024 Wocus Rd, Klamath Falls, OR 97601 ("Grantor") and People's Bank of Commerce, whose address is Commercial Lending Center, 1528 Biddle Road, Medford, OR 97504 ("Lender").

DEED OF TRUST. Lender and Grantor have entered into a Deed of Trust dated April 25, 2017 (the "Deed of Trust") which has been recorded in Klamath County, State of Oregon, as follows:

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Klamath County, State of Oregon:

Parcels 1 and 2 of Land Partition 51-09, being a re-plat of Parcel 1 of Land Partition 35-08 situated in the SE 1/4, SE 1/4 of Section 19, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, duly recorded May 5, 2010 in Volume 2010-005294, records of Klamath County, Oregon.

The Real Property or its address is commonly known as 2728 and 2738 Montellus Street, Klamath Falls, OR 97601. The Real Property tax identification number is R438887 and R896320.

MODIFICATION. Lender and Grantor hereby modify the Deed of Trust as follows:

Increase loan amount from \$250,000.00 to \$290,000.00.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
